



**Mutual Credit Union (MCU)** is looking to fill three Associate Volunteer Member positions. Associate Volunteer Members, like full Volunteer Members, have the same duties and responsibilities with the exception of voting rights. Associate Volunteer Members are part of MCU's Volunteer succession plan allowing individuals to gain knowledge of MCU and the business of financial services to prepare for a position as a voting member of the Board of Directors.

The Associate Volunteer Members have the opportunity to participate in Board meetings, Committee meetings, and Volunteer activities to learn how the Volunteers function in their role of providing guidance and counsel to MCU management.

The purpose of the Volunteers is, on behalf of the membership, to assure that MCU reaches its agreed upon goals in the best interest of the membership.

To be eligible for the Associate Volunteer Member position, a candidate must meet the following requirements.

- Must have a minimum of five years' experience in their chosen vocation or profession.
- Must be a member of MCU in good standing with a minimum 680 FICO credit score.
- Must have no obligations with MCU that are or have been delinquent.
- Must have no financial obligation with any other institution, company, or agency extending credit, which are presently delinquent or have been delinquent in the past and have no bankruptcies.
- Must have no felony convictions, or pending felony charges.
- Must sign the confidentiality form.

The Volunteers meet monthly to review the progress of MCU towards its strategic goals. Volunteers are encouraged to complete the educational courses of the Credit Union National Association's Volunteer Achievement Program for Board of Directors and to attend the Mississippi Credit Union Association's Annual Meeting and Convention.

This is a great opportunity to be a part of a successful organization and to contribute toward MCU's continued growth and success.
